New charter application – No new charter applications.

CHAPS (Challenged Horseman and Pintos) – Motion made by Sue Ellen Parker, seconded by Kathleen Gallagher to send this as a recommendation to the Show and Contest Committee. Motion passed.

ROM Point and High Point Awards – Darrell Bilke presented a list of ROM classes that are available through Pinto. We are working on this list, adding show codes, etc.

Breed Trends – Darrell Bilke discussed how Pinto compares to other equine breeds in our membership and registration numbers.

World Show Contract – Darrell Bilke let the EC know that we are in the process of working a ten year contract with Tulsa Expo for the World Show.

Proposals to add an Amateur Masters award to the Hall of Fame. Motion made by Wendy Davidson to accept the proposal and send it to the Amateur Committee to consider, seconded by Roger Altman, motion passed.

Proposal to change the rules on the Zone Rivalry to allow team members to be from different zones. Motion made by Kathleen Gallagher to amend the proposal to include state shows only and send it to the Amateur and Youth Committees to consider, seconded by Barbara Hulsey, motion passed.

Proposal to add year-end Novice awards. Motion made by Roger Altman seconded by Sue Ellen Parker to accept proposal and send recommendation to Amateur and Youth Committee. Motion passed.

Animal Welfare/Abuse - Darrell Bilke reminded everyone this issue needs to be kept current.

Corporate partners – Darrell reviewed the corporate partners that have been procured for 2014.

New employees, Shauna Ford and Alannah Castro were introduced.

Legal Counsel, Terry Wiens spoke to the Executive Committee for a few moments.

Long Range Planning recommendations presented by Chairman, Joe Grissom. Joe discussed issues that the Long Range Planning committee has talked about. There were many suggestions on different ideas for PtHA to work on implementing.

Joe let the group know that PtHA has been approached about the possibility of aquiring some real estate property. The Long Range Planning Committee suggested Darrell Bilke look into the details.

Field Representative Program – recommended to give Darrell Bilke authority to clean up the Field Rep program and the ability remove Field Reps that are repeatedly not doing the job correctly. Motion made by Roger Altman, seconded by Barbara Hulsey to implement this change. Motion passed.

Show Management Seminar – Motion made by Kathleen Gallagher seconded by Barbara Hulsey, to look into producing a webinar of the Show Management Seminar, with the possibility of having a test to certify them. Then later require them to attend every so often to be able to be a PtHA Show Secretary. Motion passed.

5000 # Sale – recommend implementing a plan to give different color or numbered back number at the World Show and Congress that is interest in selling their horse. The show office will keep the contact info and then if someone is interested in that information they can contact the office. Charge \$100 for the number. This way Pinto is not involved in the sale in any way. Motion made by Sue Ellen Parker, seconded by Roger Altman to pursue. Motion passed.
