Accounting Department / Membership - Dorothy Fread talked about the procedures of the membership and accounting offices.

International / Youth / Amateur – Emily Wolf-introduced the Gallagher Infinity marketing proposal that has been approved by the Executive Committee, reported about the USLGE meeting and how we can use that money to help promote Pinto in Sweden, Australia and New Zealand. Emily introduced the new Gist buckles for World Show and Youth and Amateur Champion buckles next year. She also introduced new Corporate Partners for 2017.

Magazine / Marketing / Media / Website – Rachael Doner covered enews blast, website traffic, video streams from the World Show and Color Breed Congress, adding a new Fiebing's Youth Exhibitor of the month, Banixx Solid horse of the month, the new corporate partner kiosk, updating membership brochure, social media numbers for facebook, twitter and Instagram. PtHA produces four magazines online per year, newsletters mailed to all members guarterly. Rachael encouraged the use of the classified ads on our website.

Show Department/ SOAR – Shauna Ford introduced new classes for the World Show: Ranch Rail Pleasure and Ranch Trail, solid miniature classes and new Utility classes to include Draft horses. Shauna covered the additional invitations for the Zone Invitational to include the top 4 zone winners this year. She reported the new SOAR program numbers of participants are increasing and new award this year for overall Amateur and Youth Zone winners will receive buckles.

IT Department - Fred Kinder talked about the new trademarks that PtHA has. We have purchased a few new computers this year, camera equipment for videoing World Show and Color Breed Congress and new LED florescent bulbs in the office to help save on electric bill. Fred gave statistics for Revenue/Sales per employee, Pinto is on the top of that scale.

Registration Dept/ Judges – Kim Hall reported Registrations for 2016 were 1629, up 1% from last year, transfers were 1221, down 8%. Judges Committee had 21applications, 11 were chosen to attend CBC, we had 10 that attended and received their PtHA judges card.

 - Add verbiage in registration requirements to clarify our rules after the APHA rule changes.
- "APHA horses registered under the RG-070-E rule will be considered on an individual basis."

Breed Council Rule Change Proposals were presented by President Elect, Kathleen Gallagher

Proposal #2017-1 - Proposed change to Rule W.10.B to read: ROM Points – No ROM points are *will be* awarded to any Walk/Trot Division Class, as this is an entry level division. Passed to Breed Council by Show and Contest Committee, passed to Breed Council by the Youth Committee. Defeated in Breed Council.

Proposal #2017-2 - Proposed change to Rule U.5.E to read: Points earned in this division will count toward PtHA Amateur Walk-Trot Year End certificate awards only. Points in this division will not count toward any PtHA ROM or Advanced Awards. Defeated in Amateur Committee, passed to Breed Council by the Show and Contest Committee. Defeated in Breed Council.

Proposal #2017-3 - Proposed change to Rule T.1, C.2 – Add to showmanship rule: No knots allowed below the tail muscle. Defeated in Show and Contest Committee.

Proposals from the International Committee, presented by Kim Hall.

- 1. Any approved charter outside of North America will be branded as the Pinto Horse Association of said country. Motion made to approve by Jenny LaGrange, seconded by Walter de la Brosse, motion passed.
- 2. There will be one charter allowed in a country outside of North America. Motion made to accept by Kathleen Gallagher, seconded by Terri Wirthlin, motion passed.
- 3. International Charter Applications with 10-24 members will be given a conditional charter for up to two years and then re-assessed. Motion made to accept by Kathy Thomas, seconded by Annette Pitcher, motion passed.
- 4. An "International Exhibitor Event" as a "Reverse Educational Mission" in conjunction with USLGE to be held at the World Show. Motion made to accept by Marty Hedgren, seconded by Carolyn Washburn, motion passed.

President Altman entertained suggestions to help improve the Zone Invitational participation.

Nell Tekampe started a discussion about starting a Professional Horseman's group within PtHA. Motion made by Joe Grissom seconded by Walter de la Brosse to start this program. Motion passed for the office staff to develop and implement the program with the approval of the Executive Committee.
